Internet Access

- ✂ I hereby authorizes the publication of my name and photography in the member directory available on the Aeroclub website.
- ✂ I am aware that all flight-related data (ie, engine operation, flying time, altitude and location) is continually recorded during plane operation and may be accessed, depending on its nature, by either the public at large or by authorized club personnel, as documented in the Internal Regulations Book and the club's Exploitation Manual.

Excerpts from the ACD's Internal Regulations Book

The aeroclub is no commercial company nor bank institution. It holds only funds provided by its members. It follows that:

- ✂ It cannot, nor is entitled to, consent to any credit whatsoever to any of its members.
- ✂ The rule is that all members should keep their account positive.
- ✂ It is up to each member to keep watch on their account balance.
- ✂ If, by exception, the account of a member should become negative, a 10 percent penalty of the debit would be withdrawn from their account by month's end.

*** All subscriptions subject to Board's approval**

* In case of accident or incident, a disciplinary board will convene and will assess responsibilities. A financial contribution amounting to 60 times the annual subscription fee may be requested from the member responsible for the damage, whether permanent or visiting pilot. The penalty may be doubled in case of evident and deliberate violation of the ACD's Internal Regulations Book or Exploitation Manual, Manex.

Any positive account balance left untouched for two years after a member has left the club will be considered a club's asset.

FOR JUNIOR MEMBERS

In their training phase, student pilots are required to conduct solo flights with no instructor on board. By signing this document, both parents or legal representatives of the minor member declare that they are aware of this, and authorize the Aéroclub du Dauphiné to let their child / protégé execute those flights.
